Biography of Rick Thachuk

Born and educated in Canada, Mr. Thachuk began his career in June 1988 at the Bank of Canada (Ottawa, Ontario), the nation's central bank responsible for setting national monetary policy and intervening in foreign exchange markets, and the Canadian counterpart of the Federal Reserve Board in the United States. As an Economist in the Department of Monetary and Financial Analysis, he participated in the study of gross monetary and credit aggregates and their implications for general economic activity and inflation. He then moved to the Foreign Exchange Division of the International Department which is responsible for the Bank's intervention in foreign exchange markets. While there, Mr. Thachuk initiated and developed the foundation for a gold call option-writing program as a way for the Exchange Fund Account, the principal repository of the country's official international reserves, to earn incremental revenues on its bullion gold holdings.

Thereafter, Mr. Thachuk moved to New York City to become the Economist and Derivatives Market Strategist of FINEX, the financial instruments division of the New York Board of Trade – the oldest futures and options exchange in New York. In this position which he held from August 1992 to December 1995, he designed and authored numerous brochures and trading and hedging guides on the Exchange's listed financial futures and options contracts including foreign currency products – especially the U.S. Dollar Index – and Treasury Note products. Toward the end of this period, Mr. Thachuk spearheaded the creation, registration and development of the first ever futures and options exchange contract market on an index of emerging market debt, dubbed the EMDX, comprised of Latin American Brady Bonds.

This position also enabled him to round-off and complete his futures and derivatives knowledge: after having been exposed to a theoretical and fundamental background at the Bank of Canada, his experience at a New York futures exchange provided unique insights into futures trading at the broker and floor trader level.

From January 1996 to July 1997, Mr. Thachuk worked as a consultant to Euro Brokers, the nation's largest brokerage of over-the-counter emerging market debt instruments, where he designed and managed an arbitrage program with the newly designed EMDX futures contract. This arbitrage program not only generated relatively risk-free revenue but also provided the necessary liquidity to the Exchange's contract market.

In August 1996, Mr. Thachuk founded World Link Futures, Inc. (visit web site at <http://www.worldlinkfutures.com>) as a commodity brokerage to specialize in serving a neglected segment of the marketplace: the beginning futures and options trader. Mr. Thachuk realized that the rapidly-growing Internet provided an effective yet inexpensive means to freely disseminate information to, and thereby educate, beginners and this gave World Link Futures an edge over its competitors. The emphasis on education became so paramount that a decision was made in mid 2001 to change the registration of the Company to that of an educational Commodity Trading Advisor. The Company, since inception, has been registered with the United States regulatory authorities and has a clean disciplinary history.

Under his guidance, World Link Futures has expanded to a network of related web sites, referred to as the *WLF Futures, Options and Forex Education Network*, that has become a leading Internet educational resource for beginning futures, options and Forex traders. Out of thousands of web sites, the Network regularly occupies the top position on Google search results for the key words, “futures trading beginner”, “futures options beginner” and “commodity trading beginner” among others.

Mr. Thachuk has authored and has been quoted in articles that have appeared in various industry publications including Futures magazine, Futures & Options World Magazine, Treasury Management and the Financial Post (see below). Mr. Thachuk has also written a bi-weekly educational column for beginners on the web site of Futures Magazine that is still being carried under its *Futures Classroom* section.

Mr. Thachuk has a Master of Arts in Economics received from the University of Western Ontario (1988), with specialization in econometric model-building, and an Honors Bachelor of Arts in Business Administration and Economics received from Brock University (1987) with specialization in International Finance.
